Key Responsibilities

- ☞ Report to management concerns about residual risk, vulnerabilities, and other security exposures, including misuse of information assets and non-compliance.
- ☞ Assess security requirements and controls, and ensure that security controls are implemented as planned during application development or acquisition.
- ☞ Collaborate on critical IT projects to ensure that security issues are addressed throughout the project life cycle
- ☞ Perform control and vulnerability assessments, Penetration tests, red teaming exercises to identify control weaknesses, and assess the effectiveness of existing controls, and recommend remedial actions.
- ☞ Define testing criteria for systems and applications.
- ☞ Develop and validate baseline security configurations for operating systems, applications, and networking and telecommunications equipment.
- ☞ Provide support and analysis during and after a security incident, as necessary.
- ☞ Assure monitoring of daily or weekly reports, and security logs for unusual events, is being done effectively and efficiently.
- ☞ Participate in security investigations and compliance reviews.
