**Recruitment of Project Staff**

The Climate Smart Irrigated Agriculture Project (CSIAP) implemented by the Ministry of Agriculture, Lands, Livestock, Irrigation, Fisheries and Aquatic Resources and funded by the World Bank is for a period of 7 years (2019 to 2025). The objective of the Project is to improve the agriculture productivity via improving climate resilience agriculture in climatically vulnerable hotspot areas identified in six provinces namely North Western, North Central, Eastern, Northern, Uva/ Southern. The estimated cost of the project is USD 125 Mn.

Applications are invited from citizens of Sri Lanka for the following posts in the project on contract basis. The applicants should possess the following qualification and experience given under each category.

**A brief Job description:**

The Project Director will have overall responsibility for the overall performance of the national level and 5 provincial DPD offices established to implement the project.
