POST OF MAINTENANCE & PROJECT ENGINEER (ELECTRICAL) (ON CONTRACT)

1.0 Job Responsibilities:

- Providing electrical engineering design inputs for the construction and renovation projects undertaken by the Bank.
- Planning the new electrical infrastructure facilities, upgrading/expansion of existing electrical systems and implementation of those plans to ensure the availability of infrastructure facilities and services required for the smooth operation of the Bank.
- Project management of construction, renovation and infrastructure development/upgrading projects.
- Administrating contracts related to consultancy services.
- Procurement process related to construction, renovation, infrastructure development/upgrading projects and consultancy services of the Bank.
- Maintaining of daily reports on existing Electrical Systems.
- Checking the payment requests and making recommendations

2.0 Required Minimum Qualifications & Experience:

A bachelor's degree specialized in Electrical Engineering obtained from a local or a foreign University, recognized by the University Grants Commission of Sri Lanka with Charter in Electrical/Building Services issued from the Institution of Engineers, Sri Lanka.

AND

Work experience of not less than 10 years after completion of the degree/graduation in the areas of maintenance of high voltage systems, generators, low voltage power distribution systems and extra low voltage systems **OR** in the field of design and construction of low voltage and extra low voltage systems. Preference will be given to candidates having energy saving experiences.

Applicants are strictly advised to submit copies of the certificates relevant to the educational/professional qualifications & work experience. Any application without the copies of the above documents will be rejected without any notice at any stage of the recruitment process.

3.0 Age:

Below 40 years of age as at 27.11.2024

4.0 Employment:

On contract basis for a period not more than three (03) years. The contract will be initially signed for one (01) year and the renewal of the contract will be considered at the end of each year based on the performance.

5.0 Remuneration and Other Benefits:

All-inclusive taxable monthly allowance of Rs. 400,000.00 with contributions to Employees' Provident Fund (EPF) and Employees Trust Fund (ETF).

Selection Procedure

Candidates will be shortlisted based on their qualifications and work experience. Most suitable candidate for the above post will be selected by an interview/s conducted by the Bank.

Candidates who fail to provide originals of relevant documents at the certificate verification conducted prior to the interview, will not in any manner be considered as eligible candidates.

Any form of canvassing will be a disqualification.

CBSL has the discretion to decide the relevancy of experience as to match the requirements of the CBSL, in shortlisting the applications.
