# Reduction of Landslide Vulnerability by Mitigation Measures Project

# VACANCY

Applications are invited from Sri Lank an citizens for the position of IT Specialist under the Reduction of Landslide Vulnerability by Mitigation Measures Project (RLV MMP) funded by the Asian Infrastructure Investment Bank (AIIB) and the Government of Sri Lanka (GoSL), with a project value of US\$ 101.3 million. The Ministry of Defence acts as the executing agency with the National Building Research Organisation (NBRO), under the Mini stry of Defence, serving as the implementing agency. The project aims to mitigate landslide risks at 128 identified locations across the districts of Badulla, Kandy, Matale, Kegalle, Ratnapura, Nuwara Eliya, Kalutara, Colombo, Matara, and Kurunegala, as well as unstable areas along railway tracks. Phase I successfully mitigated critical land slide-prone sites, and Phase II is now addressing the remaining sites.
